MEMBERSHIP REPORT

I must report that our membership continues to be a concern for me as your representative. As of March 1, 2004 we have only 55 members who have renewed membership for 2004, and of them 6 are life members.

The clan rolls now show a total of 75 members who have not renewed their membership to date. Of the 75 a total of 44 have not renewed for 2004, a total of 14 have not renewed from 2003 and 17 have not renewed since 2002.

I have received no explanation from them after several attempts to contact them. I am at a loss to explain the overall yearly decline in membership renewals. I will continue to work to reduce the losses and promote new memberships through seeking volunteers to act as temporary Clan Conveners to act as representatives of the Clan in their own geographical locations. It is hoped that this will help create positive exposure for the clan and increase new memberships.

I call on all members to help promote and recruit new members through their contacts with family, friends and the general public. We had only one new member for this quarter. Should any of or members wish to make comments or suggestions regarding membership please contact me directly.

LETTER FROM ROBIN BLAIR, LVO, WS LORD LYON KING OF ARMS

I had written the Lord Lyon to ask the Lyon Court what value and relationship Coats of Arms have to one another of the same name, and if Coats of Arms could be used as genealogical evidence of blood relationships. I hope this information aids your research and gives you an idea of what and how the Lyon Court views secondary source information.

In his letter dated 16 Feb. 2004 he replied:

Dear Mr. Morehead,

"Thank you for your letter of 9 February. The similarities between the first three sets of Arms that you refer to' [Morehead/ Moorehead/ Moorehead/ Muirheid Muirheid/ Muirheid Surnames] 'arise because it is part of the Scottish system that Arms granted to individuals with the same surname are designed to have a visual similarity. I am afraid that this does not prove anything about blood relationship.

As regards to the Arms in the Virginia Register, once again this would be of very limited use as evidence. This Register does not have any status in relation to the Lyon Court records. We will examine whatever evidence is provided and an entry in the Virginia Register might be helpful in confirming or corroborating something. However it would not be sufficient evidence in its own right and in the absence of any other proof as to a particular fact..."

Event Conveners

The Muirhead Clan Society and any and all regional, state and/or Event Conveners shall be non-political and non-profit. Clan members owe their political allegiance solely to their own Nation and shall not, <u>using the name of the Society</u>, take part in any political activity involving the internal affairs of any Nation.

Any and all interim Regional Commissioners, State Conveners, and/or Event Conveners for the Muirhead Clan shall be appointed by the Chief and or his or her Legal representatives i.e. The President and Council and shall serve as his or her governing authority in the region or state he or she was appointed to represent in all matters pertaining to the Muirhead Clan Societies Games and/or festival tents, and will be governed by the Bylaws of the society and under the direction of the Chief and or his or her Legal representatives ie. The President and Council to and for the benefit of all its members and general public.

All costs/ fees expenses of a Clan Convener at any event shall be the responsibility of the Convener. The Muirhead Clan Society will however provide a loaner kit also known as a Convener kit. It will be the responsibility of the Convener to return the kit when he or she is finished with the event, or reimburse the Clan for replacement of items lost or otherwise missing.

(See Convener Kit Itemized list for details).

What Is a Convener?

A Clan Convener is a clan member who wishes to convene / assemble members of the clan at a specific event and/or festival. He or She acts as temporary representer of the Clan for a specific Event and/or events as approved by the Chief and or his or her Legal representatives i.e. The President and Council.

Each Convener for the Muirhead Clan Society shall represent the society in their region or state by approval and authority of the Chief and or his or her Legal representatives i.e. The President and Council. Convening - it is FUN. But, what is it? Convening is the act of sponsoring a display (referred to as a tent) celebrating our Celtic Heritage at a Scottish and/or Celtic function, such as a Highland Games. The Convener is the individual or individuals serving as sponsors.

Convening is meeting people and telling them of their ancestry. It's a way to make new friends and bring joy to some who are not sure they would belong within a Clan. It is a Social Event.

What Does A Convener DO?

A convener represents the clan at a Scottish or Celtic festival. They schedule participation of the Clan with the sponsors of the event, coordinate attendance at the event with other members of the Clan and oversee Clan participation during the event. As a Convener you are the official extension of the Clan Society at and for a specific event and/or festival, promoting membership as well as a contact and source to help educate the public about our great Scottish and Irish heritage.

Most events require the Clan representatives to preregister before they may participate. This typically
involves completion and return of the event's
sponsorship forms. But, in some cases, the convener
may also be asked to sign an Indemnity (Hold
Harmless) Provision or other legal liability limitation
clause. While some events allow (even encourage)
the clans to participate for free, most charge a fee
ranging from \$25 to \$225 per tent/tent site.
If the event does not supply tents, tables, and chairs,
the convener is responsible for providing a tent (such
as a fly tent or sun shade) and desired tables and
chairs. Some events will rent these items - and even
help set them up.

The convener also needs to notify local membership of the events they will be attending. Ideally, this is to insure sufficient members of the Clan attend so that everyone - including the convener - may have some time as a spectator.

Finally, it's the convener's responsibility to see that the clan is represented during Clan activities such as the Clan Parade. Most of the time, this can be as simple as setting a time for everyone to meet before the scheduled activity. At times, it may require finding a volunteer participant for specific events (such as an entry in the parade of Clans). These events are a great opportunity to get the family and all kith and kin involved. At the end of the event The Convener will prepare a small report with photos if you have them and submit them to the President and Council so that they be added to the Clan newsletter about your event.

The Costs of Convening

The costs of convening can be subdivided into two categories: one-time and re-occurring. One-time costs are typically the expenses incurred with setting up (e.g. building) your display. Re-occurring are those that are incurred on an annual basis such as the fees charged by many festivals for the right to participate.

All costs will be the responsibility of the Clan Convener, save the cost of the Conveners kit.

At the end of the event the Clan flag will be kept by the Convener as a small thank you from the general membership for serving as Clan Convener.

Expenses for this kit was paid in part out of the Muirhead Clan Society General Fund and out of my personal funds. This kit will be mailed out to the Conveners as needed and it will be their responsibility to care for it and it prompt return after their event.

Stone of Destiny

During a recent visit to the Pacific north-west, during which we had the great pleasure of meeting Raymond and Yen Chi Morehead, my wife, Edna Mae, and I also visited my sister, Betty, and her husband, Andrew Whitelaw, at their home in North Vancouver, British Columbia, to celebrate the 50th anniversary of their wedding in Dundee, Scotland on 20 January 1954.

Among the fifty or so guests at the celebration at the Canadian Legion Hall in West Vancouver that evening was Mr. Gavin Vernon, formerly of Glasgow.

Gavin Vernon was one of four students who participated in the return of the Stone of Destiny from beneath the British throne in the wee hours of Christmas morning in 1950. The others were lan Hamilton, Kay Mathison and Alex Stuart.

I'd heard previously that Gavin was an acquaintance of Betty and Andy's.

While enjoying a social hour prior to the anniversary dinner and informal ceilidh, Andy pointed Gavin out to me.

I immediately went over to Gavin, and shaking his hand, expressed my admiration for the courage that he and his friends displayed fiftythree years earlier.

With a smile, Gavin simply said, "I'll tell you this much, David; had we been professionals, we would never have succeeded!"

Although I failed to broach the subject with Gavin, who, sadly, became quite ill by the end of that week, I have a strong feeling that Mr. Roland Eugene Muirhead, who might well be described as the father of the Scottish Nationalist Party encouraged this student escapade.

I remember the incident very well - that Christmas I was on leave from my army unit in Frankfurt, Germany and passed through London en route to visit friends in Dundee. Coincidentally, when the stone was recovered at Arbroath Abbey in 1951, I was again back home in Dundee.

I do, however, make no claim as to personal involvement in the act.

Bettina must have sold a million fish suppers

BETTINA DAWSON, from Moffat, has lived in a flat above the village's fish and chip shop all her life.

"The Moffat Chippy" — as it's known — was opened by her Italian parents, Pasqualina and Antonio Dicerbo, when they first moved to Scotland in 1922.

Just 11 years old when she began helping out doing old jobs, pretty soon Bettina was serving behind the counter part-time to earn pocket money.

And when she was only 13 her dad insisted she leave school to become a full-time member of the staff working in the chippy seven days a week.

During World War 2 there were barracks near Moffat, yet despite strict orders to eat only Army food, soldiers would sneak to the back door of the takeaway for some more appealing grub.

As she dished out fish suppers, Bettina struck up a friendship with a young squaddie from Huddersfield named George who, By Kirsten Gray

from then on, would always pay her a visit each time he returned from serving abroad.

Romance blossomed and they were married shortly before the end of the war. George moved into Bettina's family home above the chippy after he was demobbed — out of the line of fire and into the frying pan!

Even becoming pregnant couldn't keep Bettina away from the fryer — she worked right up until a few hours before giving birth to each of their children, Michael and Rosina.

When her mother died 30 years ago, Bettina took over the running of the chippy, yet even being her own boss has never tempted her to slow down.

A few years ago when she fell and fractured her wrist cleaning the windows, she carried on serving with her arm in plaster.

And with the exception of two fortnights a year when Bettina

and George take themselves off for a well-earned holiday, the other 337 days are spent frying.

Given that she can sell anything from 10 to 120 suppers a day, she must have sold more than a million in her career.

According to Bettina, customers come from far and wide to enjoy her fish suppers, which cost £3.50, compared with only sixpence when she first started back in the 1930s.

Ironically, while plenty of pub-goers stop off after closing time, Bettina has never touched a drink or smoked in her life.

But she does admit to one bad habit. She eats chips every day just to check they're good enough to sell, of course.

And anyone who reckons that too many fries are bad for you might like to think again.

Because despite having lived above a chippy all her life, and worked in it for 69 years. Bertina has no plans to retire — even at the grand age of 80!
